SUBJECT: Adjustment in the Federal Lodging Rate

DATE: October 1, 2019

I have been advised that effective October 1, 2019 the General Services Administration has adjusted the maximum federal standard Federal Lodging rate from the 2019 to the 2020 Fiscal Year. A copy of the adjusted rate schedule is attached.

Wyo. Stat. § 9-3-102(a) authorizes me to establish these rates, which shall not exceed the federal rates. Vendors in the industry are aware of these federal rates and often set their rates to match them; therefore it appears to be practical to set Wyoming's rates at the federal reimbursement level.

Agency Directors are authorized to reimburse State employees at the new (federal) rate for travel on authorized State business after October 1, 2019.

However, Agency Directors shall carefully examine and monitor their budgets and travel.

M&IE Total - the full daily amount received for a single calendar day of travel when that day is neither the first nor last day of travel.
